DOT is reaching out to internal bureaus for comments on PDP (project delivery plan) Setting up one on one meetings with Traffic, Geotech, Turnpikes, ROW, Utilities, etc... to discuss PDP including submission timelines and returning project plan comments in a timely manner. Roles and Responsibilities handout will be explained, and senior staff will listen to concerns. Question: Do more detailed guidelines need to be developed and set? Possibly take one page PDP into more detail during meetings?

NHDOT hesitant to post guidelines online yet until a bulleted list is developed and more internal communication has been done. Possibly CQI consultants can develop a more detailed list or Roles and Responsibilities for the Department. After more discussion it was determined the overall philosophy (current information) of more efficient project delivery would be ok to post.

- Contract Extensions (3:15 3:35)
  - i. How long is too long to adjust budget ceiling

Example of an older task order delayed for several years then being revived with consultant using older rates. Can't complete the work with budget because hourly rates are much higher. How long is it? 2 years / 3 years? This type of change to a consultant contract is difficult and would need to be explained to G&C which can be very challenging. A change in scope to the project is easier to justify. Changes to contracts have been done in the past. Language in Article 2A in consultant contracts allows for changes. This type of contract change would need to be on a case-by-case basis.
